Dr. Mark Levy, a Distinguished Fellow of the <u>American Psychiatric</u> <u>Association</u>, is a graduate of Columbia College and the <u>Columbia</u> <u>University College of Physicians and Surgeons</u>, a Diplomate of the <u>American Board of Psychiatry and Neurology</u> in Psychiatry with Subspecialty in Forensic Psychiatry and a graduate of the <u>San Francisco Psychoanalytic Institute</u>. He also received Forensic Psychiatric Training from the <u>American Academy of Psychiatry and Law</u>'s Forensic Psychiatry Board Review Course, and the Osler Institute's Forensic Psychiatry Board Review Course.

## Forensic Psychiatry, Psychiatry and Psychoanalysis

For more than thirty years, Dr. Levy has been practicing clinical psychiatry and psychoanalysis full time in Mill Valley, California. In addition, during the past twenty years he has devoted a substantial portion of his clinical practice to forensic psychiatry, providing independent medical evaluations (IME's) and expert forensic psychiatric opinion and Consultation nationally for plaintiff and defense trial attorneys, major insurance carriers and the courts. He has consulted on more than 350 medical-legal cases, has been deposed more than 175 times and has testified in State and Federal Court on 34 occasions.

# **Academic Positions and Teaching**

Since 1976, Dr. Levy has been on the clinical faculty of the <u>Department of Psychiatry</u>, <u>School of Medicine</u>, <u>University of California at San Francisco</u>, where he is currently an Assistant Clinical Professor where he participates in teaching the Forensic Psychiatry Fellows. He is also on the faculty at the <u>San Francisco Psychoanalytic Institute</u>, where he teaches psychoanalytic candidates.

### **Public Service**

Dr. Levy was the founder and served for more than a dozen years as Chairman of the San Francisco Foundation for Psychoanalysis, a community-outreach and public service organization of psychoanalysts and community members interested in mental health issues. He is also a former officer and Board member of the San Francisco Psychoanalytic Institute and Society (now renamed as the San Francisco Center for Psychoanalysis).

## **Forensic Psychiatry Professional Activities**

Together with the Bar Association of San Francisco, Dr. Levy helped establish an educational program for attorneys focusing upon psychological issues. Within this program, he has spoken on a broad array of issues covering the interface of law and psychiatry, as well as other matters affecting the two disciplines. The topics he's discussed include Post Traumatic Stress Disorder, Sexual Harassment, Psychological Trauma and Abuse, Psychological Injury, Stress, Confidentiality, Mental Competency Evaluation, Depression, Psychiatric Malpractice, Personality Disorders and Litigation, Psychotherapy, Psychoanalysis, and much more. He has also been a lecturer and panelist at MCLE events sponsored by the California State Bar Association, The Northern California Association of Defense Counsel and the Defense Research Institute in Chicago, Illinois, the Office of the Attorney General, State of California and the Department of Homeland Security, Immigration Control and Enforcement Division, as well as numerous private law firms.

#### Licenses and Certification

Dr. Levy is licensed as a physician and surgeon in the states of California (1972) and Hawaii (2004) and is licensed to prescribe controlled

substances by the United States Drug Enforcement Administration. He is a Diplomate of the National Board of Medical Examiners (1971). He is a Diplomate in Psychiatry (1981) of the American Board of Psychiatry and Neurology and was later certified in Forensic Psychiatry (1999, recertified 2009). Dr. Levy was also certified as a Qualified Medical Examiner for the State of California in 1993 and maintained his active QME status until 1996 (when he chose to become "inactive" because he was no longer conducting Workers' Compensation Evaluations).

## **Professional Organizations**

He is also a current or past member of numerous professional organizations including the American Academy of Psychiatry and the Law (a subsidiary of the American Psychiatric Association), a Fellow of the American, California and Northern California Psychiatric Associations, a member of the faculty of the San Francisco Center for Psychoanalysis (where he is also on the faculty) and the Department of Psychiatry, School of Medicine, University of California, San Francisco and the China American Psychoanalytic Alliance. He has also been a member of the American and International Psychoanalytic Associations and the International Society for Traumatic Stress Studies, the California Medical Association and the Marin Medical Society.
